

## PRODUCTION LOT CODE INFORMATION

Lot number is read as follows: The lot number is up to a 9 digit number, the first 5 digits being the date in which the product was produced. The first two digits represent the year, and the following 3 digits represent the Julian day of the year in which the product was produced. For example 18001 would represent the January 1, 2018. The fifth digit represents the production line the product was produced on. The last two digits are a sequential number that represents the order in which the batches were produced on a particular line.
